The number of sections shall be restricted in accordance with 'II' above with land requirement unit scaled down to 2000 square

meters i.e. 12 sections for every 2000 square meter additional land.

The total number of sections taken together for classes XI and XII should not be more than 1/3 of optimum number of section allowed on the basis of land holding for any school.


The number of sections and students shall be restricted as per the actual facilities in the school.

For class rooms of size less than 500 sq feet the enrolment shall be 0.08 X size of class rooms in sq feet

**Important Notes :** "Grant with Conditions:- 1) Public disclosure uploaded not seems to be as per norms. The school is required to upload mandatory public disclosure as per appendix -IX of Affiliation Bye-laws. 2) Copy of the Building safety certificate uploaded by the school is valid up to 31-12-2020. Hence, school is required to obtain renewed copy of Building Safety Certificate duly sealed and signed by the competent govt authority of the concerned department (PWD) and upload the same in the public disclosures link of the school website. 3) School has uploaded copy of Sanitary Certificate instead of submitting Fire Safety certificate in the Upload section. However a Fire NOC has been uploaded in the public disclosure with expiry date of 06-01-2019. Hence, it is not valid as on date. Therefore, School is required to obtain a valid and renewed copy of fire safety certificate issued by the Fire Safety Department of the State/UT of appropriate government authority of concerned Municipal Corporation etc. based on the inspection of the fire safety department. It should be mentioned in the certificate that the entire school building is safe in terms of fire. The same is required to be uploaded in the public disclosure link on the school website as per appendix IX of affiliation bye laws. 4) The extension is granted to the school on one time basis subject to condition that school will follow the instructions and fulfill the conditions given in the Board's circular no. 13/2021 dated 23-07-2021." School is required to appoint special educator & wellness teacher as per affiliation bye laws.
